


Output Power, I vs Input Power (PC-P1 ON, V CTL(L) =0V, f=5.9GHz)











Loss, ISL vs Input Power (PC-P1 ON, V<sub>CTL(L)</sub>=0V, f=8.5GHz) 0 -2







## ■ APPLICATION CIRCUIT




- [1] The DC blocking capacitors should be placed at RF terminals. Please choose appropriate capacitance value at the application frequency.


